Additional Information	Dress Code: The uniform must be ironed or wrinkle-free. Solid black scrub top with sleeves. Solid Black scrub pants. Pants must be hemmed and not dragging the floor. Solid Black skirts may be worn, below the knee. A long sleeve shirt (any color) may be worn under scrub top. No hoodies or sweat shirts may be worn under scrub top. Shoes: Comfortable tennis shoes or workforce shoes only. Head Attire: No hats, caps, wave or wrap caps, or bandanas. Adornment headbands are acceptable upon approval. Nails: As a safety precaution, all nails should be of average length. Nails may not be longer than the end of the finger. Hair: Hair must be neat and presentable daily. (You are your biggest advertisement) Lab Jacket or Vest: Solid Black lab jacket or vest. Approved Lamar Cosmetology t-shirts may be worn with black scrub pants. As a service professional, good hygiene is a required daily. Uniforms and shoes will be monitored and checked on a regular basis.
